# Keynote Speech One

'Qualitative and Quantitative: Two Sides of the Same Coin. Understanding and Undertaking the Methodological Debate'

### Speaker: Dr Ekaterina Kolpinskaya

Dr Kolpinskaya is a lecturer in the Politics department at the University of Swansea. Her research interests include political participation and representation of underrepresented groups such as women, ethnic and religious minorities in Western democracies, especially in Britain. She is also interested in how identity-based predictors shape the political attitudes and behaviour of political elites and members of the public. She predominantly uses quantitative and mixed methods in her research analysing survey data and text.

# Keynote Speech Two

'Ten Lessons from the Arab Springs'

# Speaker: Prof. François Burgat

François Burgat is a senior researcher in political science at the CNRS based at the IREMAM in Aix-en-Provence. He was between May 2008 and April 20 B director of the Institut français du Proche-Orient (IFPO) and earlier (1997-2003) headed the Centre français d'Archéologie et de Sciences Sociales de Sanaa (CEFAS).

Fluent in Arabic, François Burgat has devoted his career as a political scientist to the analysis of political systems and civil societies in the contemporary Arab world. In doing that he has also assumed a wide range of academic and institutional responsibilities in a large number of international instances. His approach to the various trends of Islamism has been widely recognised as innovative since he, early on, highlighted the need for the study of Arab societies to be deeply anchored in field research and the need to establish direct contact and discussions with political actors labelled as Islamist.
